On 10/31/2024 at approximately 2150 hours, I Officer Velazquez responded to the intersection of Oviedo Blvd. & Mike Roberto way in reference to a vehicle crash with injuries.

Upon arrival, I made contact with Robert William Garcia, later identified by his FL DL. While speaking to Robert, I smelled the odor of alcohol emitting from his breath. When asking Robert what occurred, Robert advised me that he did not remember what happened. Robert also did not know what direction he was traveling in when the crash occurred. Robert advised that a vehicle had struck his vehicle causing his vehicle to lose control and spin out. While speaking with Robert, I noticed indicators of impairment in him such as slurred speech, slowed reactions, bloodshot glassy eyes, and slight difficulty standing upright. Robert also had a slight orbital sway from side to side.

It should be noted that surveillance footage was captured by a parked Tesla that was involved in the accident that showed Robert to be the at fault driver. Robert's story for the crash changed multiple times when asked about the crash and did not match what occurred on surveillance.

I advised Robert that the crash investigation was concluded and began my DUI investigation. I advised Robert of my observations and asked him if he was willing to perform the Field Sobriety Exercises. Robert immediately refused to perform the FSEs.

I read Robert his Miranda Rights and asked if he understood his rights to which he refused to talk.

Based on my initial observations of Robert's indicators of impairment and Robert's refusal, I developed probable cause to place Robert under arrest for DUI. I placed Robert under arrest and transported him to the Seminole County Jail. At the jail, I turned him over to the Breath tech T. Kouri in order to collect a breath sample from Robert. Breath Tech T. Kouri advised Robert refused to provide breath samples. Robert received a DUI citation with property damages and a citation for a careless driving.
