On July 3rd, 2025, at approximately 1244 hours, officers responded to 1977 Alafaya Trail (Plato's Closet) in reference to a suspicious person/voyeurism. Officers made contact with the juvenile victims, [REDACTED] and [REDACTED], who advised the following:

On 07/02/25, at approximately 1115 hours, [REDACTED] and [REDACTED] arrived at Plato's Closet. Both juveniles wanted to try on several pieces of clothing and entered the same fitting room together. As they were changing their clothing, [REDACTED] observed an unknown male walking around pacing directly in front of the fitting room door. [REDACTED] observed the male put his phone under the door to the stall and proceed to film them. [REDACTED] immediately yelled "hey" and heard the male run away. Neither juvenile gave anyone permission to film them as they were changing in the fitting room.

[REDACTED] and [REDACTED] as well as their parents, advised they wished to seek prosecution.

Officers made contact with Plato's Closet store manager, Sophia Katherine Puentes-Quinones, who provided store surveillance footage which captured the incident. The footage captured the following:

1110 hours- Brian enters Plato's Closet.

1124 hours- Brian walks near the fitting rooms and clearly notices the victims changing inside one of the rooms.

1125 hours- Brian displays his cellphone, intentionally drops a pair of pants he was holding near the changing room door and filmed the victims underneath the door while retrieving his pants.

1126 hours- Brian intentionally drops the pants again and filmed another video of the victims as he grabs the pants from the floor.

1127 hours- Brian browses around the store and returns to the fitting room for a third time.

1128 hours- Brian took two more videos of the victims until [REDACTED] observes his phone and alerts him by screaming "hey".

1129 hours- Brian immediately exits the store without making a purchase.

On 07/08/25, an attempt to identify bulletin of the suspect was posted on the Oviedo Police Department Facebook page. It should be noted, this page is accessible to the general public. Johnny Wilson observed the bulletin and was able to positively identify the suspect as his current roommate, Brian Bishop. Johnny immediately contacted emergency services to notify them of Brian's whereabouts.

Officers made contact with Brian at his residence and placed him into custody. Brian was notified of his Miranda Rights, which he acknowledged full understanding of. Brian was transported to the Oviedo Police Department for further questioning.

Det Salemi and I conducted an interview with Brian at the Oviedo Police Department. Brian saw the attempt to identify bulletin and confirmed the suspect was him. Brian admitted to going to Plato's Closet on 07/02/25 and seeing two girls in the changing room. Brian admitted to using his cellphone to take several videos of the girls with the intention of capturing them nude/undressing. Brian further explained his intention for filming the victims was "perverse" in nature. Brian was startled by one of the victims seeing his cellphone under the stall door and screaming "hey", prompting him to exit the store immediately. Brian stated he immediately deleted the videos he took of the victims as he was still exiting the store.

Due to the aforementioned circumstances, I believe probable cause exists Brian Bishop violated F.S.S. 810.145 (2) SEX OFFENSE DIGITAL VOYEURISM BY PERSON 19+ YOA 1ST VIOL.

Brian committed this violation when he intentionally used his cellular phone to record both [REDACTED] and [REDACTED] for his own amusement for the sole purpose of degrading them while they used the privacy of the changing room to undress. [REDACTED] and [REDACTED] were recorded at a time and setting where they were undressing, and they had a reasonable expectation of privacy. The video recording was without the knowledge or consent of either [REDACTED] or [REDACTED].
